3. BID SUBMISSION

The original completed bid documents must be submitted in a sealed envelope endorsed with the Bid Number and Bid Description as detailed in the Tender Data. The sealed envelope must be deposited in the Bid/Tender Box, located in the reception area of Amatola House, 6 Lancaster Road, Vincent, East London, not later than the time and date specified on the cover page and SBD 1 of this bid.

4. **DISQUALIFYING FACTORS**

7. JOINT VENTURE REQUIREMENTS

<u>DEFINITION</u>:- "Joint Venture or Consortium": means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

Should a group of companies/firms and/or interested parties wish to enter into a joint venture / Consortium agreement the following minimum requirements must be met: -

- a. A properly signed copy of the joint venture/consortium agreement must be attached.
- b. Each member of the joint venture/consortium's taxes must be in order.

Scope of Work:

TERMS OF REFERENCE APPOINTMENT OF A SERVICE PROVIDER TO PROVIDE ICT PROFESSIONAL SERVICES

1. PURPOSE

Amatola Water wishes to engage a competent service provider to enter into a service level agreement for the provision of a reliable, efficient government compliant, system administration services and related resources at an agreed rate for second- and third-line ad-hoc support of seven-hundred (700) normal hours over a twenty-four (24) month period.

2. BACKGROUND

Amatola Water has a data centre consisting of virtualised servers on 7 physical servers. The Organisation has a Microsoft Enterprise Agreement in place. The internal network is largely dominated by Dell equipment with a minority part of the network being Cisco. The goal of this bid is to procure ICT Professional Services at competitive rates from a reliable, qualified service provider to provide ad-hoc support service at an agreed hourly rate. Our Head Office and Nahoon Dam Data Centres currently comprises of the following server hardware and storage:

- a) Rack Mountable Servers (DELL)
- b) VEEAM Recovery software
- c) Redstor backup agent for Head Office and Nahoon servers

3. OBJECTIVES AND GOALS

By having a second/third line ad-hoc support, the Organisation seeks to achieve the following goals:

- a) Provide efficient and reliable ICT services.
- b) Be able to resolve ICT incidents speedily.

4. SCOPE OF THE WORK

4.1 Ad-hoc maintenance and support of the following existing services at AMATOLA WATER offices:

6. METHODOLOGY
