Amatola Water invites quotations from suitably experienced suppliers to provide the goods for the Hiring of an Excavator and Lowbed to transport the Excavator to Nolitha Special School at Mount Ayliff with the Driver Operator as set out below:

SCOPE OF WORK

A. 6 weeks contract exclusive of weekends to hire an Excavator and Lowbed (2 days delivery of the machine and collection of the machinery) with the Driver Operator for excavator the borehole water rising main at Nolitha Special School at Mount Ayliff.

Evaluation Criteria

- Locally based i.e. surrounding suppliers will be considered (Mthatha Region)
- Proof of ownership will be a requirement.
- Provision of previous experience as an Excavator supplier (at least 3 references)
- Delivery Period of not more than 3 days after the receiving the order.

Scope of work:

- 1. The Excavator must be quoted on daily wet rate and have its own operator.
- 2. Operator must produce the following:
 - a. Proof of competence that the operator can operate the machine.
 - b. Medical certificate of fitness.
- 3. Rain delayed days will not be billed but recorded as non-productive hours/days.
- 4. Transport of the Excavator to and from the project area will be rated separately.
- 5. Accommodation and food, if applicable, for Plant operator must be arranged by Plant Hire Company and must be included in the daily rate quoted.
- 6. Security and liabilities of the Plant machinery is the responsibility of the Plant Company and Amatola Water won't be held responsible for any losses or damages to the machine.

- The driver –operator of the machine shall comply with the Health and Safety regulation.
- The service provider will submit a summary of the hours after the machine has been used, or after the job has been completed if it's a short period, which will be certified for payment by the foreman or responsible person and Manager according to the weekly records.
- Amatola Water reserves the right to increase or decrease the contract period or number of Excavator required or any part thereof if project work on the contract is cancelled or work has come to an end. This will be communicated to the contractor in advance when and for how long the contract will be stopped/cancelled/ceases.
