Should a group of companies/firms and/or interested parties wish to enter into a joint venture / Consortium agreement the following minimum requirements must be met: -

- a. A properly signed copy of the joint venture/consortium agreement must be attached.
- b. Each member of the joint venture/consortium's taxes must be in order.

	 Ensure the equipment used to decant is clean and not contaminated.
	Decant the water into the required storage facility.

3	Response time in hours, once notified to start loading water
