### 8. JOINT VENTURE REQUIREMENTS

<u>DEFINITION</u>:- "Joint Venture or Consortium": means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

Should a group of companies/firms and/or interested parties wish to enter into a joint venture / consortium agreement the following minimum requirements must be met: -

Amatola Water invites quotations from suitably qualified and experienced service providers for the FOR PROVISION OF LIQUID CHLORINE GAS FOR THE PERIOD OF THREE (3) YEARS

### **BACKGROUND**

Amatola Water (AW) is a state-owned water utility established in November 1997 and is mandated to render water services to water sector institutions, local government and other customers in the Eastern Cape.

Amatola Water is providing its services according to the Sections 29 and 30 of the Water Services Act and seeks to find a suitable and cost effective supply of polymeric chemicals for the water treatment works it operates. The current chlorine contract expired on 30 June 2022, necessitating a new contract to be in place for the next three years.

#### 1. SCOPE OF WORK

AW intends to appoint a suitably experienced and qualified liquid chlorine gas supplier for the supply and delivery of Liquid Chlorine Gas to Amatola Water treatment plants. The following is covered in the scope of work:

- Ensuring that Amatola Water receives uninterrupted supply of chlorine gas to various sites.
- Supply, delivery and offloading of chlorine gas to various water treatment plants in Amatola Water. The liquid chlorine gas shall be able to produce drinking water that complies with SANS 241 quality standards.
- Delivery of the stock will be for Primary business of Amatola Water e.g:
  - o Nahoon WTW, Laing WTW, Peddie WTW, Glenmore WTW, Sandile WTW, Debe WTW, Binfield WTW, Masincedane WTW and Albany Coast.
- Delivery of stock for new business of Amatola Water.
  - Amatola Water reserves the right to increase/decrease quantities as Amatola Water enters into new business during this contract period.
- The successful supplier has to conform to national water safety standards e.g. National Sanitation Foundation (NSF), South African Bureau of Standards(SABS) and World Health Organization (WHO). Product must be certified for use in Potable water
- The supplier shall comply with lead times and delivery times to be specified in the tender document.
- The supplier shall be duty bound to supply a certificate of analysis for each batch of delivery.
- The supplier shall use transport that complies with safety requirements for transportation of hazardous chemicals.
- The driver also must be a certified Hazardous Chemical driver.
- All chlorine tanks 940 or 990Kg and cylinders 70Kg supplied must be compatible with the existing Amatola Water equipment/systems.
- Mandatory safety signage and information Material Safety Data Sheets (MSDS), connecting and disconnection procedures, emergency contact list and any other applicable signage must be supplied for the products.
- It is required of the successful supplier to provide six (6) accredited training sessions with all training material for approximately 20 Amatola Water staff per session with specific regard to the safe use, handling and transporting of liquid chlorine gas.
- Annual audit of the chemical major hazardous installations and supply report.
- Annual testing and calibration of chlorine alarm and supply certificate.
- The supply of the pigtails shall be included into the contract.
