

2. BID SUBMISSION

3. <u>RFQ Evaluation Criteria</u>

This bid will be evaluated in Two (2) phases:

1. BACKGROUND

Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District, and portions of adjoining districts in the central Eastern Cape.

2. SCOPE OF WORK

Amatola Water invites suitably qualified and experienced professional service providers to quote on supplying Amatola Water with REPAIRS OF OUTSPAN BULK LINE 600mm STEEL PIPE AND REPLACEMENT BY +-600mm X 6m GALVANIZED STEEL FLANGED ON ONE SIDE .

3. SPECIFICATION

The objective of the tender process is to appoint service providers to submit proposals for the Provision of bulk supply line Repairs in Amatola Water:

The following is covered in the scope of work:

- To enable replacement and repairs on pipeline, demolish reinforced concrete chamber and thrust wall.
- Remove existing 600mm spool piece and valve.
- Supply and install 600mm dia. galvanized pipe flanged on one side and plain ended on the other side and a 600mm dia. flange adaptor.
- Repair/reinstate concrete chamber wall.
- Backfill and rehabilitate the area.
- All works is suggested to be finished in a 24-hour cycle.
- All excavations, backfilling and rehabilitation to be done with an aid of a TLB provided by successful Service Provider.
- Successful service provider to provide for a detailed health and safety plan that will be submitted to Amatola Water Safety Office for approval.
- All repetitive work in less than 30 days in the same spot will be remedied at contractor's expense.
- Retention period shall apply to all works for a period of not less than 30 days.
- Amatola Water reserves the right to increase or decrease the contract period or any part thereof if project work on the contract is cancelled or work has come to an end. This will be communicated to the contractor in advance when and for how long the contract will be stopped/cancelled/ceases.




