Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.

Amatola Water is a State-owned, Water Services Enterprise established in terms of the Water Services Act. As a Public Utility, its prime function is to provide water services to Municipalities, industry and other communities. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.

2. SCOPE OF WORK


