7. JOINT VENTURE REQUIREMENTS

DEFINITION:- “**Joint Venture or Consortium**”: means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

Should a group of companies/firms and/or interested parties wish to enter into a joint venture / consortium agreement the following minimum requirements must be met: -

- a. A properly signed copy of the joint venture/consortium agreement must be attached.
- b. Each member of the joint venture/consortium's taxes must be in order.
- c. After the award of a contract to a joint venture/consortium, the successful joint venture group or consortium must provide a combined joint venture/consortium Tax Clearance Certificate.
- d. After the award of a contract to a joint venture/consortium, the successful joint venture group or consortium must provide the details of the joint venture / consortium banking details.

BID SPECIFICATION

Amatola Water invites quotations from suitably qualified and experienced service providers for the Collection of Bio-Hazardous Waste and Providing Waste Boxes.

1. BACKGROUND

Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.

2. SCOPE OF WORK

3. This is a rates based RFQ up to a limit threshold of R 500 000 including VAT.

BACKGROUND

The objective of the RFQ is to appoint suitably experienced and professional service providers to submit quotation for the collection of the Bio-Hazardous Waste generated by the Scientific Services Department. The disposal of biological waste is regulated by the Department Environmental and Tourism. The supply of the biological waste services is required at the Laboratory of Amatola Water in East London.

SCOPE OF SERVICES

- Collection and disposal of all types of waste currently generated by Amatola Water Laboratory as often as required

Types of Waste

- Colilert waste plastic trays
- Petridishes with media
- Reference Cultures
- Mixed Cultures

- be responsible for the safe loading, removal and transportation, consolidation (if applicable) and disposal of the Hazardous Waste; in accordance with the prevailing legislation and in terms of this Agreement, while protecting Amatola Water, the environment and the public from unsound waste management practices;
- ensure that all statutory laws and other legislation pertaining to the handling, removal, transportation and disposal of Hazardous waste are complied with;
- The Tenderer must comply with the minimum standards for the disposal of General Waste and Hazardous Waste.
- provide a service in which the interest of public health, hygiene and anti-pollution be paramount and will ensure clean and tidy areas without any accumulation of waste and will prevent the spread of infectious and contagious disease;

The following is covered in the scope of work:

- To collect the biological waste generated by the laboratory

- To supply the waste boxes and chemical waste containers.
- The supplier shall also include disposal certificate
- The waste should be collected on a monthly basis or on special request

The vehicle used should meet the minimum std.

WASTE BOXES TURNAROUND TIMES

Ensure that the waste receptacle is provided timeously but within a maximum period of forty- eight hours (48) after having been notified.

DISPOSAL OF WASTE

The Contractor shall ensure:

- that the disposal of the Hazardous waste at the registered Waste Management Site complies with all national, provincial and local legislation and/or other applicable legislation;
- that the disposal of the waste at the registered Waste Management Site is always supervised by and be subject to the direction and approval of the duly authorised person, Waste Management Site manager or employee in charge of the registered Waste Management Site;
- that all Hazardous Waste is disposed of at a registered H:H and/or H:h Landfill Site;
- that it obtains a duly signed manifest for each load of Hazardous Waste disposed of at the registered H:H and/or H:h Landfill Site

SPILLAGES BY THE CONTRACTOR

The Service Provider must ensure that all necessary and reasonable measures are taken to prevent the spillage of any waste in the Amatola Water Laboratory, on public roads, onto third party property and into and onto the environment, during the loading, removal, transportation, and disposal of the waste.

The cost of any spillage clean up shall be for the sole account of the Contractor and the Contractor hereby indemnifies Amatola Water against all costs, charges and claims of whatsoever nature and howsoever arising which may be made against it by any person, entity or organisation.

The Service Provider shall ensure that in the event of a spillage occurring it:

- immediately inform the Amatola Water of the incident as well as remediation measures undertaken;
- the vehicle and all affected areas must be appropriately cleaned and sanitised after disposal;
- that the chemicals used by the Service Provider, in the clean-up process are bio-degradable and that the Service Provider will ensure that the chemicals will not contaminate storm water and / or cause any damage or harm to the environment;
- that the Service Provider has adequate hazmat resources;
- that the Service Provider will not leave the affected area until the spillage has been completely cleaned-up to the satisfaction of the environmental authorities.

DURATION OF CONTRACT

The contract is expected to run for three years, commencing on the date of signing the Service Level Agreement. It will, however, be renewable annually and this will be subject to a review of the previous year's performance.
