Should a group of companies/firms and/or interested parties wish to enter into a joint venture / consortium agreement the following minimum requirements must be met: -

Amatola Water invites quotations from suitably qualified and experienced service providers for the **Removal of Domestic Waste and Supply of Refuse Bags in Nahoon and Laing Dam Complex**

1. BACKGROUND

Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.

2. SCOPE OF WORK

- Provision of Two (2) Bulk Containers/Waste Bins for Nahoon Dam Complex comprising 36 houses and One (1) Bulk Container/Waste Bin for Laing Dam Complex comprising 12 houses and be located where it is going to be accessible for the dwellers to dispose. This will simplify collection instead of collecting from each dweller.
- Collect domestic waste once a week from 48 houses .
- Supply a pack of 25 bags to the 48 houses every second month
- It is the service provider's responsibility to obtain and pay for disposal coupons from Buffalo City Metropolitan.
- Integrated Pollution and Waste Management (Department of Environmental Affairs and Tourism [DEAT], 2000), the NWMS and the Waste Act, which recognize the importance of moving waste management up the waste hierarchy (i.e. greater emphasis on waste avoidance, minimization and recycling to reduce impacts further downstream) (Nahman & Godfrey, 2010).
- PPE and workman's compensation for the Refuse Collectors must be arranged by Successful Service provider and be included in the rate quoted.
- Amatola Water reserves the right to increase or decrease the contract period. This will be communicated to the contractor in advance when and for how long the contract will be stopped/cancelled/ceases.
- Preference will be given to locally based service providers ,ie Amathole District Munisipal Area
