All Bids must remain valid for a period of 90 (ninety) days from the closing date as stipulated in the Bid document.

6. AUTHORITY TO SIGN BID DOCUMENTS

In the case of a Bid being submitted on behalf of a company, close corporation or partnership, evidence must be submitted to the Amatola Water at the time of submission of the Bid that the Bid has been signed by persons properly authorised thereto by resolution of the directors or under the articles of the entity.

Form A must be completed. Failure to complete Form A must invalidate your bid.

7. JOINT VENTURE REQUIREMENTS

DEFINITION:- “Joint Venture or Consortium”: means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

Should a group of companies/firms and/or interested parties wish to enter into a joint venture / consortium agreement the following minimum requirements must be met: -

- a. A properly signed copy of the joint venture/consortium agreement must be attached.
- b. Each member of the joint venture/consortium's taxes must be in order.
- c. After the award of a contract to a joint venture/consortium, the successful joint venture group or consortium must provide a combined joint venture/consortium Tax Clearance Certificate.
- d. After the award of a contract to a joint venture/consortium, the successful joint venture group or consortium must provide the details of the joint venture / consortium banking details.
- e. A trust, consortium or joint venture will qualify for points of their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- f. SCOPE OF WORK.

Provision of OHS& E Legal registers per identified site based on site specific AMATOLA WATER activities, environmental aspects and impacts.

Legislation interpreted in simple language indicating how it is applicable to the AMATOLA WATER activities linked to environmental aspects and safety hazards.

Provision of OHS&E legal registers on a cloud/web based solution.

Registers which can be viewed from the whole of AMATOLA WATER as well as to be able to be viewed – filtered – to site specific level.

A legal evaluation checklist (for undertaking internal compliance audits) to be compiled based on the site specific registers from both an environmental and occupational health & safety compliance audit.

The legal requirements must be searchable by (i) key words (ii) actual activities linked to aspect register or the aspect categories (iii) actual activities linked to safety hazard or hazard categories(iv) legislation - to facilitate searching for applicable legal requirements.

Ability to identify, link to and describe the relevant AMATOLA WATER OHS&E “control” policy, process control manual (PCM), procedure and standard and how compliance is monitored, managed and the risk rating.

Ability to add other AMATOLA WATER related documents & records requirements and to load documents or hyperlink documents on registers. (A mechanism to load authorisations, license or permit conditions into the registers.)

Access to all the applicable EH&S legislation and legal requirements from the Constitution of South Africa, to National, Provincial and include related regulation and guidelines.

Access to all applicable EH&S Local legislation (bye-laws) including related regulations, guidelines must be included in the legal register.

Provision of 6 monthly updates and easy of updating the system (These registers will then need to be updated to ensure inclusion of applicable new legislation or removal of repealed OHS&E legislation. Update based on changes in AMATOLA WATER’S structure and new developments will result in the need for the development of new OHS&E Legal register on a case by case basis.)

Provision of monthly updates (Flash reports or notification regarding new legislation must be sent to AMATOLA WATER informing of upcoming changes (both for gazetted draft legislation published for comment and final legislation gazetted) in legislation and the implications to AMATOLA WATER. Flash reports with updates or notification should be communicated on monthly basis on the Legal Register.

The vendor must provide an implementation plan to manage the implementation, including liaising with AMATOLA WATER resources to complete the necessary change. management processes and logging deployment changes.

Able to provide acceptable support to the system.

Service provider to provide a training module (both training material presentation slides and learners manual) that AMATOLA WATER can use for internal training.
