BID SPECIFICATION

SCOPE OF WORK

The objective of this process is to invite suitably experienced and professional service providers with Three references to submit proposals for the Provision of Grass-cutting, tree pruning or felling where required and Gardening Services.

These services will be required at the following sites:

- Head Office at Vincent East London
- Laing Dam WTW (Including the following residential areas)
 - House # 3; 4 & 6
 - Pipeline – House # 1 to 5
- Nahoon Dam Complex (Including the following residential areas)
 - House # 6 - Loerie Street,
 - House # 1; 3; & 8 - Jejane Circle
- Water Resources at Vincent, East London
- Any other sites that may arise

***Due to the size of the working areas bidders are required to have a Chain saw, Tractor or a Rear operated mower (KUDU) and Bush-Cutter.**

Garden Services required include but not be limited to:

- Cutting of grass.
- Furrows in areas of grass cutting to be cleaned out.
- Brush cutting bedding edges and general tidying of beds.
- Trees / Shrubs to be trimmed.

The above specification also refers:

- Cutting will be required once when Amatola Water deems it necessary.
- Flowerbeds must be cleaned and cultivated once.
- All grass cuttings, clippings and garden refuse must be dumped at a designated site.
- In case of inclement weather the grass cutting must commence immediately afterwards.
- Amatola Water will not be held responsible for any loss or damage of Contractor's plant and machinery.
- Areas in Vincent must be serviced within two (2) days of commencement of work, i.e. work is to be completed within two (2) day period.
- The bigger areas, such as the Nahoon Complex, must be completed within 3 to 4 days of commencement.
- It is required of the successful bidder to advise Amatola Water when they are unable to resume work on the next anticipated service date, thus enabling Amatola Water to monitor the suppliers performance.
- Brush-cutters only to be used at the Water Works. Other areas require the use of a Tractor and Bush-Cutter or a Rear Operated grass cutter. These will be indicated on site meeting.
- Ensure that Amatola Water receives uninterrupted grass-cutting and gardening services.
- The supplier shall supervise the rendering of the services to ensure they comply with all the safety requirements at all times.
- A Health & Safety Plan must be submitted by the successful bidder at least 2 days prior to the implementation of the contract.

Amatola Water reserves the right to increase or decrease the listed sites to meet Amatola Water's strategic requirements.
