The original completed bid documents must be submitted in a sealed envelope endorsed with the Bid Number and Bid Description as detailed in the Tender Data. The sealed envelope must be deposited in the Bid/Tender Box located in the reception area of Amatola House, No.6 Lancaster Road, Vincent, East London, not later than the time and date specified on the cover page and SBD 1 of this bid.

## **6. AUTHORITY TO SIGN BID DOCUMENTS**

In the case of a Bid being submitted on behalf of a company, close corporation or partnership, evidence must be submitted to the Amatola Water at the time of submission of the Bid that the Bid has been signed by persons properly authorised thereto by resolution of the directors or under the articles of the entity.

**Form A must be completed. Failure to complete Form A must invalidate your bid.**

## **7. JOINT VENTURE REQUIREMENTS**

**DEFINITION:- “Joint Venture or Consortium”:** means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

Should a group of companies/firms and/or interested parties wish to enter into a joint venture / consortium agreement the following minimum requirements must be met: -

- a. A properly signed copy of the joint venture/consortium agreement must be attached.
- b. Each member of the joint venture/consortium's taxes must be in order.
- c. After the award of a contract to a joint venture/consortium, the successful joint venture group or consortium must provide a combined joint venture/consortium Tax Clearance Certificate.
- d. After the award of a contract to a joint venture/consortium, the successful joint venture group or consortium must provide the details of the joint venture / consortium banking details.
- e. A trust, consortium or joint venture will qualify for points of their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- f. ## **BID SPECIFICATION**

### **1.MAJOR HAZARD INSTALLATION REGULATIONS.**

Amatola Water requires an experienced service provider to be appointed to conduct a full risk assessment as per the **Major Hazard Installation Regulations** under the Occupational Health and Safety Act of 1993 to determine the potential for causing major incidents (i.e. incidents that can affect the public outside the perimeter of the facility and the employees as well). Such a risk assessment will be used to assess whether there are sufficient emergency plans and facilities in place to deal with any such major incident, should it occur.

#### **a. SCOPE OF WORK**

The MHI assessment will be carried out to comply with the requirements of the revised Major Hazard Installation Regulations of July 2001, under the South African Occupational Health and Safety Act. The assessment will also comply with any known MHI requirements of the Local Authorities.

### **3.IT IS PROPOSED THAT THE PROJECT WILL PROCEED AS PER THE BELOW:**

#### **Step 1: Information gathering and incident identification:**

- A visit to the sites to gather all relevant information e.g. material listings, inventories, design drawings, process conditions and flow rates, maps, weather data, key operating instructions, emergency procedures, details of process safety management systems in place, failure modes e.g. rupture, leaks, venting etc. An evaluation of the types of activities surrounding the site will be undertaken.
- Conduct discussions with operational staff and or members of the H&S Committee (if available) to identify hazards and agree risk assessment terms of reference.
- Identify potential major hazardous incidents associated with the installation. Potential knock-on effects to neighbouring facilities will also be included.
- To submit a preliminary list of identified incidents to Amatola Water for review (and for consultation with their H&S committee if available). The list will include the process design/operation parameters that will be used in the assessment and the client will be required to verify the parameters are suitable. Agree a final list of potential MHI incidents to be quantified.

## STEP 2 – Quantification

### Determine the magnitude of the agreed hazardous incidents in terms of:

- Size of the loss of containment, or internal explosion.
- Gathering relevant data
- Hazard identification
- Hazard analysis
- Consequence analysis
- Risk calculations (including individual and societal risk)
- Risk judgement criteria
- Risk treatment
- Land-use planning
- Duration of the incident.
- Perform a consequence analysis to identify the effects of **applicable** hazards e.g.: Pool formation, spread and evaporation to obtain the emissions;
- Dispersion to obtain aerial exposure concentrations.
- Explosion and radiation circles.
- Consequences of key events such as radiation zones and overpressure radii will be plotted suitable land use maps.
- For each incident determine the consequences and estimate the severity in terms of fatalities.
- Quantify the likelihood of the MHI events based on generic data derived from databases, or estimations from the experience of the operating personnel, or in the case of critical events by the compilation of fault trees. The failure data will be adjusted based on a brief evaluation of the Safety Management System likely to be in place at the facility.
- Based on the population activities around the site estimate the population risk weighting factors to be used.
- Combine the likelihood and severity of the major hazards to produce individual risk estimates i.e. quantitative representations of the risks.
- Compile weighted individual risk profiles for the installation, and weighted individual risk contours (isopleths  $10^{-5}$  and  $10^{-6}$  or less) indicating the possible impact of weather conditions and wind directions. Public and employee MHI type risks will be addressed.
- A societal risk estimation will be presented in the form of an F-N curve.
- Assess these risks by making value judgments in terms of internationally recognized quantitative acceptability criteria as well as any criteria available from the national, provincial and local authorities.
- Review the on-site emergency plans and where necessary provide ideas on any possible improvements in the light of the risk assessment results.

### STEP 3 – Technical Report

- For the installation, compile all the information, analysis, assessments and conclusions as detailed above into a DRAFT risk assessment report. The report will comply with the requirements of SANS1461 for MHI Ras.
- Submit **DRAFT** report to Amatola Water for comment.
- After receipt of comments finalize the above technical report into an MHI Risk Assessment Report suitable for Notification.
- SHEQ Department will render assistance wherever possible to ensure the project progresses as planned.
- The SHEQ Department must be notified prior to site visit.
- **The above to be completed within one (1) month from date of award.**
