Should a group of companies/firms and/or interested parties wish to enter into a joint venture / consortium agreement the following minimum requirements must be met: -

BACKGROUND

Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.

BID SPECIFICATION

The objective of the tender process is to appoint service providers to submit proposals for the Provision of TLB and Rollback services to work in Mount Coke, King William's Town and surrounding area to perform maintenance work, digging of pipe trenches and water pipeline installations or any other adhoc work required by the TLB.

Note: The work will be maintaining leaks on water bulk pipeline, a start & stop kind of work. During this period, the TLB will be requested on call-out basis to come to site when requested and TLB transport trips will be paid as per request to leave site or come back to collect TLB.

The following is covered in the scope of work:

- The Plant machinery must be quoted on an Hourly wet rate and have its own operator.
- TLB to be able to travel between sites on its own within the Laing Dam WTW and Mount Coke Bulk Water Network.
- The Rollback to be quoted on Km travelled within the stipulated Km not to be exceeded.
- The minimum normal hours per day shall be charged at eight hours (8 hrs) per full days worked. Any time over the normal time will be charged as overtime but the rate quoted won't change. (to be the same as normal rate).
- The operator must be competent to excavate a trench within or between surrounding existing services and according to levels provided by the foreman or responsible person.

- The owner of the machine shall submit proof of ownership as a requirement when submitting his quote.
- The owner of the machine shall submit the daily working hours of the machine every Monday of the week with hours that will be compared with the records of the Amatola Water foreman or responsible person.
- The operator of the machine shall comply with the Health and Safety regulations of the Occupational Health and Safety act.
- TLB must be in a good road worthy condition
- The service provider will submit a summary of the hours after the machine has been used which will be certified for payment by the foreman or responsible person and Manager according to the weekly records.
- The fuelled (Back Actor)TLB with competent operator who can excavate at prescribed slopes with the use of profiles shall be used to excavate trenches,0.5m - 1.5m deep for the laying of pipelines up to 350mm and will be used for any other general purposed were Back Actor can be used.
- The bucket width shall be between 450mm and 600mm for TLB.
- Accommodation, food, PPE and workman's compensation for the TLB Operator must be arranged by Supplier and be included in the daily rate quoted.
- Security and liabilities of the Plant machinery is the responsibility of the Plant Company and Amatola Water won't be held responsible for any losses or damages to the machine.
- Any downtime of the Plant TLB due to own problems e.g. operator not available on site, breakages etc. will be deducted from the agreed full day hours to be worked and must be shown on the daily logbook for reconciliation purposes.
- Any breakages or TLB replacement on the machine must be responded to within 24 hrs.
- Plant machinery must be available on site when requested by the successful supplier outside of agreed work hours.
- Amatola Water reserves the right to increase or decrease the contract period or number of TLB's required or any part thereof if maintenance or project work on the contract is cancelled or work has come to an end. This will be communicated to the contractor in advance when and for how long the contract will be stopped/cancelled/ceases.
