Amatola Water invites quotations from suitably qualified and experienced service providers for the **PROVISION OF LAUNDRY AND CLEANING SERVICES**

1. BACKGROUND

Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.

2. SCOPE OF WORK

The objective of this process is to invite suitably experienced and professional service providers with Three references to submit proposals for the Provision of Valet and or Dry Cleaning to floors, Fumigation of Administration Block and Houses in Nahoon Dam Complex.

These services will be required at the following sites:

- Administration Building Nahoon Dam
- Married Quarters Nahoon Dam
- Plots Nahoon Dam

***Due to the size of flooring and buildings being currently occupied. Dry cleaning and fumigation of the floor carpets in areas specified is qualification.**

Services required include but not be limited to:

- Dry Cleaning to carpet floors.
- Fumigation of offices and houses in Nahoon Dam Complex.
- Valet and upholster chairs where necessary (using a similar fabric).

- Bidders are required to provide a National Contract Cleaners Association Certificate or equivalent and or proof of previous experience.

The above specification also refers:

- Dry Cleaning of carpet floors is required once when Amatola Water deems it necessary for offices and houses.
- Valet to office chairs one seater Couches; two seater Couches and three seater Couches once.
- All facilities must be serviced within Twenty (20) days of commencement of work, i.e. work is to be completed within Twenty (20) day period.
- Office areas, such as the Administration building, must be completed within 3 to 4 days of commencement.
- It is required of the successful bidder to advise Amatola Water when they are unable to resume work on the next anticipated service date, thus enabling Amatola Water to monitor the suppliers performance.
- The areas that require the service varies according to building size and specified coverage. These will be indicated on site meeting.
- Ensure that Amatola Water receives uninterrupted cleaning and fumigation services.
- The supplier shall supervise the rendering of the services to ensure they comply with all the safety requirements at all times.
- A Health & Safety Plan must be submitted by the successful bidder at least 2 days prior to the implementation of the contract.
