1. EVALUATION CRITERIAS-DISQUALIFYING FACTORS

 PROOF OF BUSINESS ADDRESS: Lease Agreement / Municipal Bill or Letter of Residence from Ward Councilor. Should the bidder be operating in more than one district municipality, proof of business address is required for each office. Bidders who resides outside of Eastern Cape are also expected to provide proof of their business address.

- PROOF OF OWNERSHIP REGISTERED UNDER THE BIDDING COMPANY or PROOF OF LEASING - Leasing Agreement or Letter of intent to lease must be submitted with the bid.
- Truck Size allowed: Only 8 tonnage trucks with capacity to deliver a single load of 10 000L and above will permitted.
