Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.

- Ensure that the old coating adheres to the substrate.

- Apply two coats of white Plascon Wall and All low sheen paint to all internal walls.
