1. BACKGROUND AND INTRODUCTION

Amatola Water requires the service of a suitable qualified service provider to supply an Automated titration System for the analysis of the pH, Alkalinity, Conductivity and Fluoride in water samples. The Tenderer shall supply, deliver, install, commission, and train the laboratory staff to operate the instrument. The instrument and any accessories supplied should be fully automated.

2. SCOPE OF WORK

The following is covered in the scope of work:

- The Titration System must offer a high degree of analysis flexibility for potable water, surface water, ground water, saline water, wastewater, industrial effluents, process waters and soil / sludge digests
- The tenderer must prove they have supplied similar equipment/instrument, with contactable numbers for reference.
- The System should be capable of detection limits exceeding the requirements of SANS241:2015 levels. Deviation from any of the parameter SANS241:2015 requirements is to be specified
- The titration system supplied should include all necessary accessories required for the operation of the equipment i.e. analyzer, instrument controller and software.
- Where certain reagents used in the instruments are ready made, such are to be available for usage in order to allow for full automation and eliminate time consuming reagent preparation. Tenderers are to supply a list of **reagents available, working ranges and costs**.
- Calibration features to include linear, bias or non-linear calibration, polynomial curve fitting and modification.

The system must be supplied, complete, to include accessories to enable functioning for the following, as minimum:

- Sample Robot with built-in inputs for reference, temperature and ISE electrodes,
- Built-in membrane pumps and built-in peristaltic pumps,
- The system should have barcoding capabilities to provide automatic loading of samples
- It must be capable of simultaneously analyse pH, Conductivity, and Alkalinity to provide quick measurement
- Independent and removable sample racks with a total sample capacity of 40 positions (minimum). Sample beakers with a ± 100 mL capacity.
- Automatic addition of buffer for Fluoride analysis
- pH Electrodes for pH and alkalinity analysis
- Ion Selective and Reference Electrode for Fluoride Analysis
- System controlled by via PC with software

Auto-titrator

- The system must be able to analyse water samples for:
 - Fluoride content in ppm using Ion Selective measurements
 - pH and alkalinity using pH electrode
- Be able to increase sample capacity by the addition of sample racks
- Exchange batches of samples on a running system

- Standalone titrators with built-in burette drives
- The system must have washing station to prevent sample cross contamination

Capable of carrying out parallel analysis

Flexibility to change the burette drive volumes by changing the burette drive accessory

Titration should be available with or without a magnetic stirrer

Functions via existing or stand-alone network

Software

- Software should be intuitive the software should be based on Industry Standard MS-Windows Environment.
- The software shall be multi-tasking and multi-user with the capability to report live results to (amongst others) LIMS, Excel and Word using default and custom templates.
- Automatic export at the completion of automated analysis shall be possible using at least two templates.
- Graphical method editor with drag and drop functionality
- Led status indication that show whether all components are configured and working properly
- All sample data at one place
