### **5. PERIOD OF VALIDITY FOR BIDS AND WITHDRAWAL OF BID AFTER CLOSING DATE**

All Bids must remain valid for a period of 90 (ninety) days from the closing date as stipulated in the Bid document.



## **6. AUTHORITY TO SIGN BID DOCUMENTS**

In the case of a Bid being submitted on behalf of a company, close corporation or partnership, evidence must be submitted to the Amatola Water at the time of submission of the Bid that the Bid has been signed by persons properly authorised thereto by resolution of the directors or under the articles of the entity.

**Form A must be completed. Failure to complete Form A must invalidate your bid.**

## **7. JOINT VENTURE REQUIREMENTS**

**DEFINITION:- “Joint Venture or Consortium”:** means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

Should a group of companies/firms and/or interested parties wish to enter into a joint venture / consortium agreement the following minimum requirements must be met: -

- a. A properly signed copy of the joint venture/consortium agreement must be attached.
- b. Each member of the joint venture/consortium's taxes must be in order.
- c. After the award of a contract to a joint venture/consortium, the successful joint venture group or consortium must provide a combined joint venture/consortium Tax Clearance Certificate.
- d. After the award of a contract to a joint venture/consortium, the successful joint venture group or consortium must provide the details of the joint venture / consortium banking details.
- e. A trust, consortium or joint venture will qualify for points of their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- f. A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate tender.

## **THE JOINT VENTURE/CONSORTIUM AGREEMENT MUST CONTAIN THE FOLLOWING: -**

- a. Who the managing member will be.
- b. Who the signatory of authority will be.
- c. How the joint venture/consortium share of profit will be split.
- d. The bank account details where payments will be deposited into.
- e. The agreement must be signed by all parties.
- f. The agreement must be certified by a Commissioner of Oaths.
- g. The postal and physical address where all correspondence will be sent to

## **8. CONDITIONS OF TENDER**

## **BID SPECIFICATION**

### **LEGAL COMPLIANCE SERVICES SCOPE OF WORK**

All services must be provided by qualified and experienced legal consultants according to the quality and performance standards expected of service providers of a similar stature.

#### **Legal Register**

The Service Provider must provide, maintain, and update the Amatola Water Occupational Safety, Health and Environmental (SHE) Legal Register according to the following requirements and standards.

The Service Provider must identify and document applicable SHE legal requirements based on the activities of the Amatola Water

The legal register must include SHE legal requirements on a National, Provincial (Eastern Cape) and local (Buffalo City Municipality) level.

The legal register must include a list of SANS Codes that are incorporated into applicable legislation, and which are therefore legal requirements. Due to copyright restrictions by the SABS, the actual content of SANS Codes cannot be included in the legal register.

Non-applicable legal requirements must be filtered out, making the legislation more accessible to those who need to manage compliance. Only those provisions placing an obligation, prohibition or significant legal risk on the register user must be included in the register.

Applicable legal requirements must be explained where possible in user-friendly terms, with the elimination of legal jargon.

Applicable legal requirements must be made accessible in electronic format (MS Word or Excel) facilitating ease of use in other compliance tools such as training, reports, incident investigations, audits, management plans, memorandums, etc.

The Service Provider may not impose restrictions on putting the register on the client's intranet for access to all employees for example, and any software licensing and user fees must be specifically indicated. Availability of the legal register must be under the control of the client, and not dependent on internet access or server availability from the Service Provider's side.

The Service Provider must maintain the legal register through an update process, where the user will receive any changes in legislation, new legislation, or repealed legislation must be removed from the legal register. A Record of Changes must indicate the changes made for each update.

Updates can be emailed to ensure efficient delivery. Updates should be sent as soon as reasonably possible depending on the circumstances, but at least within 90 days of any applicable change.

Subject to the scope of the legal register and agreement between the Service Provider and the client, the Service Provider must address any valid certification or other audit findings on the legal register communicated by the client.

The Service Provider must provide reasonable telephonic and email support to the client regarding the content and use of the legal register.

### **Legal Links in Risk Assessment**

The Service Provider must update relevant legal references included in the client's SHE risk assessments whenever there is an update to the legal register. The client will provide the latest version of the risk assessment to the Service Provider.

### **Legal Compliance Audit**

The Service Provider must conduct an annual SHE legal compliance audit on Amatola Water. The audit must achieve the following objectives:

To assess the extent of the client's compliance with applicable SHE legislation (as contained in the legal register).

To evaluate the effectiveness of any implemented management system of the client to ensure legal compliance and reduce risks.

To present a report to the client on the current status of compliance and make recommendations to address the deviations.

To advise the client on in improving legal compliance management.

To determine whether there are any "other requirements" to which the client subscribes that should be audited, and to verify compliance to such requirements where applicable.
