## **6. AUTHORITY TO SIGN BID DOCUMENTS**

## **7. JOINT VENTURE REQUIREMENTS**

**DEFINITION:- “Joint Venture or Consortium”:** means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

Should a group of companies/firms and/or interested parties wish to enter into a joint venture / consortium agreement the following minimum requirements must be met: -

- a. A properly signed copy of the joint venture/consortium agreement must be attached.
- b. Each member of the joint venture/consortium's taxes must be in order.
- c. After the award of a contract to a joint venture/consortium, the successful joint venture group or consortium must provide a combined joint venture/consortium Tax Clearance Certificate.
- d. After the award of a contract to a joint venture/consortium, the successful joint venture group or consortium must provide the details of the joint venture / consortium banking details.
- e. A trust, consortium or joint venture will qualify for points of their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- f. Amatola Water invites quotations from suitably qualified and experienced service providers for the **HIRING OF TLB (BACK ACTOR) WITH OPERATOR AND ROLLBACK FOR PIPELINE REPAIRS IN AMATOLA WATER DISTRIBUTION SYSTEMS AS AND WHEN REQUIRED BASIS**

### **BACKGROUND**

*Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.*

### **Specification**

The objective of the contract process is to appoint service providers to submit proposals for the Provision of TLB with Operator and Rollback services in the entire Amatola Water area of service:

#### **The following is covered in the scope of work:**

- The Plant machinery must be quoted on a daily wet rate and have its own operator.
- Rollback must be quoted on provisionally in the event the TLB or Excavator needs to be transported or moved to or from site to your depot or to another location.
  - Km rate.
- The minimum normal hours per day shall be charged at eight hours (8 hrs) per full day.
- The operator must be competent to excavate a trench within or between surrounding existing services and according to levels provided by the foreman or responsible person.
- The owner of the machine and the Rollback shall submit the daily working hours and kilometres of the machine and Rollback every Monday of the week which hours will be compared with the records of the Amatola Water foreman or responsible person. Machine must be equipped with an hour meter which records only when engine is running.
- The operator of the machine shall comply with the Health and Safety regulations of the Occupational Health and Safety act.
- TLB and the Rollback must be in a good road worthy condition
- The service provider will submit a summary of the hours and kilometres worked and travelled or after the machine has been used, or after the contract period has seised, which will be certified for payment by the responsible person and Manager according to the weekly records.
- The fuelled (Back Actor) TLB with competent operator who can excavate at prescribed slopes with the use of profiles shall be used to excavate trenches, 1.5m to 2m deep for the laying of pipelines up to 750mm and will be used for any other general purposed were Back Actor can be used.

- The bucket width shall be between 450mm and TLB.
- Security and liabilities of the Plant machinery is the responsibility of the Plant Company and Amatola Water won't be held responsible for any losses or damages to the machine.
- Any downtime of the Plant TLB due to own problems e.g., operator not available on site, breakages etc. will be deducted from the actual hours worked and must be shown on the daily logbook for reconciliation purposes.
- Any breakages or replacement on the machine must be responded to within 4 hrs.
- Plant machinery must be available on site when requested by the successful supplier outside of agreed work hours.
- Amatola Water reserves the right to increase or decrease the contract period or any part thereof if project work on the contract is cancelled or work has come to an end. This will be communicated to the contractor in advance when and for how long the contract will be stopped/cancelled/ceases.
