4. RFQ Evaluation Criteria

RFQ will be evaluated on the below factors:

8. JOINT VENTURE REQUIREMENTS

DEFINITION:- “Joint Venture or Consortium”: means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

Should a group of companies/firms and/or interested parties wish to enter into a joint venture / consortium agreement the following minimum requirements must be met: -

- a. A properly signed copy of the joint venture/consortium agreement must be attached.
- b. Each member of the joint venture/consortium’s taxes must be in order.

BACKGROUND

Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.

TERMS OF REFERENCE

APPOINTMENT OF A SERVICE PROVIDER TO PROVIDE ICT PROFESSIONAL SERVICES

1. PURPOSE

Amatola Water wishes to engage a competent service provider to enter into a service level agreement for the provision of a reliable, efficient government compliant, system administration services and related resources at an agreed rate for second- and third-line ad-hoc support of **seven hundred (700)** normal hours over a twenty-four (24) month period.

2. BACKGROUND

Amatola Water has a data centre consisting of virtualised servers on 7 physical servers. The Organisation has a Microsoft Enterprise Agreement in place. The internal network is largely dominated by Dell equipment with a minority part of the network being Cisco. The goal of this bid is to procure ICT Professional Services at competitive rates from a reliable, qualified service provider to provide ad-hoc support service at an agreed hourly rate. Our Head Office and Nahoon Dam Data Centres currently comprises of the following server hardware and storage:

- a) Rack Mountable Servers (DELL)
- b) VEEAM Recovery software
- c) Redstor backup agent for Head Office and Nahoon servers

3. OBJECTIVES AND GOALS

By having a second/third line ad-hoc support, the Organisation seeks to achieve the following goals:

- a) Provide efficient and reliable ICT services.
- b) Be able to resolve ICT incidents speedily.

4. SCOPE OF WORK

4.1 Ad-hoc maintenance and support of the following existing services at AMATOLA WATER offices:
