### **2. BID SUBMISSION**

The original completed bid documents must be submitted in a sealed envelope endorsed with the Bid Number and Bid Description as detailed in the Tender Data. ### **3. RFQ Evaluation Criteria**

#### **1. BACKGROUND**

*Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.*

#### **2. Scope**

##### **Specification**

1. The objective of the contract process is to appoint service providers to submit proposals for hire and Provision of Medium size Excavator with driver to transport excavator.
2. Service Providers to submit proposal for hire and provision of 4x4 Crane truck to transport 80 x 315mm PVC Class 20 pipes for distance of 20km return trip, your rates must be inclusive of the Driver operator and loading and offloading assisting labour.

4x4 Crane Truck at a wet rate with Operators and Labour for transportation of pipes,

Lowbed for transportation of Excavator to and from site for the Tsholomqa Mainline Refurbishment in Amatola Water with the specification as tabled below:

##### **The following is covered in the scope of work:**

- The Plant machinery must be quoted on daily/hourly wet rate and have its own operator.
- Lowbed must be quoted for Excavator for transportation to and from site.

➤ Km rate.

- The minimum normal hours per day shall be charged at eight hours (8 hrs) per full day.
- The Excavator operator must be competent to excavate within or between surrounding existing slopes and services according to levels provided by the foreman or responsible person.
- The owner of the machinery, Crane Truck and the Lowbed shall submit the daily working hours and kilometres of the machine, Crane Truck and Lowbed every Monday of the week which hours will be compared with the records of the Amatola Water foreman or responsible person. Machine must be equipped with an hour meter which records only when engine is running.
- The operator of the machine and Crane Truck shall comply with the Health and Safety regulations of the Occupational Health and Safety act.
- All machinery, the Lowbed and Crane Truck must be in a good road worthy condition.
- The service provider will submit a summary of the hours and kilometres worked and travelled or after the machine has been used, or after the contract period has seized, which will be certified for payment by the responsible person and Manager according to the weekly records.
- The fuelled Machinery with competent operator who can excavate at prescribed slopes with the use of profiles shall be used to excavate for existing pipeline trenches and Replacement of pipework on Tsholomqa mainline.
- Security and liabilities of the Plant machinery is the responsibility of the Plant Company and Amatola Water won't be held responsible for any losses or damages to the machine.
- Any downtime of the Plant Excavator and Crane Truck due to own problems e.g., operator not available on site, breakages etc. will be deducted from the actual hours worked and must be shown on the daily logbook for reconciliation purposes.
- All response times upon callouts should be strictly kept at 3 hours for the excavator operator.
- Any breakages or replacement on the machine must be responded to within 4 hrs.
- Plant machinery must be available on site when requested by the successful supplier outside of agreed work hours.
- Amatola Water reserves the right to increase or decrease the contract period or any part thereof if refurbishment work on the contract is cancelled or work has come to an end. This will be communicated to the contractor in advance when and for how long the contract will be stopped/cancelled/ceases.
