Phase One: Mandatory Requirements

4. AUTHORITY TO SIGN BID DOCUMENTS

In the case of a Bid being submitted on behalf of a company, close corporation or partnership, evidence must be submitted to the Amatola Water at the time of submission of the Bid that the Bid has been signed by persons properly authorised thereto by resolution of the directors or under the articles of the entity.

5. JOINT VENTURE REQUIREMENTS

DEFINITION:- "Joint Venture or Consortium": means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

Should a group of companies/firms and/or interested parties wish to enter a joint venture / consortium agreement the following minimum requirements must be met: -

1. BACKGROUND

Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.

2. Scope

Specification

The objective of the contract process is to appoint service providers to submit proposals for the Provision of TLB, Excavator, Operators, Lowbed and Rollback services in the entire Amatola Water area of service with the specification as tabled below:

• TLB

The following is covered in the scope of work:

- The Plant machinery must be quoted on a hourly/daily wet rate and have its own operator.
- Rollback/Lowbed must be quoted on provisionally in the event the TLB needs to be

transported or moved to or from site to your depot or to another location.

- ➤ Km rate.
- The minimum normal hours per day shall be charged at eight hours (8 hrs) per full day.
- The operator must be competent to excavating within or between surrounding existing services and according to levels provided by the foreman or responsible person.
- The owner of the machine and the Rollback/Lowbed shall submit the daily working hours and kilometres of the machine and Rollback/Lowbed every Monday of the week which hours will be compared with the records of the Amatola Water foreman or responsible person. Machine must be equipped with an hour meter which records only when engine is running.

- The operator of the machine shall comply with the Health and Safety regulations of the Occupational Health and Safety act.
- All machinery Rollback/Lowbed must be in a good road worthy condition and or working condition.
- The service provider will submit a summary of the hours and kilometres worked and travelled or after the machine has been used, or after the contract period has seized, which will be certified for payment by the responsible person and Manager according to the weekly records.
- The successful service provider shall provide competent TLB/Excavator operator with fuelled TLB/Excavator who can excavate at prescribed slopes with the use of profiles on pipeline distribution networks in Amatola Water distribution systems.
- The plant shall be stored in Nahoon dam for the duration of hire that is 60 days as and when needed. Security and liabilities of the Plant machinery will be the responsibility of the Plant Company outside Amatola Water premises and Amatola Water will be responsible for the overnight storage. Amatola Water will not be held responsible for any losses or damages to the machine caused by recklessness.
- Any downtime of the Plant (TLB/Excavator) due to own problems e.g., operator not available on site, breakages etc. will be deducted from the actual hours worked and must be shown on the daily logbook for reconciliation purposes.
- Any breakages or replacement on the machine must be responded to within 4 hrs.
- Plant machinery must be available on site when requested by the successful supplier outside of agreed work hours.
- Amatola Water reserves the right to increase or decrease the contract period or any part thereof if project work on the contract is cancelled or work has come to an end. This will be communicated to the contractor in advance when and for how long the contract will be stopped/cancelled/ceases.
- 25% of the hourly rate will apply on TLB and Excavator as compensation of standing.


