All Bids must remain valid for a period of 90 (ninety) days from the closing date as stipulated in the Bid document.

5. AUTHORITY TO SIGN BID DOCUMENTS

In the case of a Bid being submitted on behalf of a company, close corporation or partnership, evidence must be submitted to the Amatola Water at the time of submission of the Bid that the Bid has been signed by persons properly authorised thereto by resolution of the directors or under the articles of the entity.

Form A must be completed. Failure to complete Form A will invalidate your bid.

6. JOINT VENTURE REQUIREMENTS

<u>DEFINITION</u>:- "Joint Venture or Consortium": means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

Should a group of companies/firms and/or interested parties wish to enter into a joint venture / consortium agreement the following minimum requirements must be met: -

- a. A properly signed copy of the joint venture/consortium agreement must be attached.
- b. Each member of the joint venture/consortium's taxes must be in order.

Amatola Water invites quotations from suitably qualified and experienced service providers for the RATE-BASED SERVICES REQUIRED ON MAINTENANCE REPAIRS OF POLE AND SURFACE MOUNT TRANSFORMERS FOR AMATOLA WATER PLANTS.

BACKGROUND

Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.

1. SCOPE OF WORK

RATE-BASED SERVICES REQUIRED ON MAINTENANCE REPAIRS OF POLE AND SURFACE MOUNT TRANSFORMERS FOR AMATOLA WATER PLANTS.

- 1. Maintenance Repairs of the Pole and Surface mount of the following transformer sizes:
- 2. 25KVA to 2,5 MVA, 11Kv/400V, 11kV/3.3V/400V to 22kV/400V,22kV/3.3kV/400V supply line.
- 3. Supply of parts and various components of the specified transformers STRICTLY for Repairs ONLY.
- 4. New installation of the specified transformers.
- 5. Fault finding and root cause analysis on transformers specified.

Requirements

- Evaluation Criterion will include workshop visits of the bidders to <u>verify the existence and</u> the location of the business.
- Repairs will be conducted through call outs on breakdowns and on scheduled maintenance.
- Successful bidder will be required to travel to all Amatola Water sites to carry out repair works.
- The turnaround time for the service provider to be on site after the call has been logged is limited to Three (3) hours.

The amount of work at a given point of time will be determined by the number of breakdowns and the planned maintenance.
