1. DEFINITIONS

The word "Bidder/Tenderer" in these conditions shall mean and include any firm of Contractors, Suppliers, Service Providers or any company or body incorporated or unincorporated.

1. BID PUBLICATION

2. BID SUBMISSION

3. RFQ Evaluation Criteria

This bid will be evaluated in Two (2) phases:

Phase One: Mandatory Requirements

- Bidders' proposals must meet the following minimum requirements and the required supporting documents must be submitted with the completed quotation document, nonerasable ink, no tippex or correctional fluid used in a sealed envelope in the bid box at the closing date and time. Failure to comply will automatically eliminate the bid for further consideration:

All Bids must remain valid for a period of 90 (ninety) days from the closing date as stipulated in the Bid document.

5. AUTHORITY TO SIGN BID DOCUMENTS

In the case of a Bid being submitted on behalf of a company, close corporation or partnership, evidence must be submitted to the Amatola Water at the time of submission of the Bid that the Bid has been signed by persons properly authorised thereto by resolution of the directors or under the articles of the entity.

Form A must be completed. Failure to complete Form A will invalidate your bid.

6. JOINT VENTURE REQUIREMENTS

DEFINITION:- "Joint Venture or Consortium": means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

Should a group of companies/firms and/or interested parties wish to enter into a joint venture / consortium agreement the following minimum requirements must be met: -

- a. A properly signed copy of the joint venture/consortium agreement must be attached.
- b. Each member of the joint venture/consortium's taxes must be in order.
- c. After the award of a contract to a joint venture/consortium, the successful joint venture group or consortium must provide a combined joint venture/consortium Tax Clearance Certificate.

Amatola Water invites quotations from suitably qualified and experienced service providers for the **PROVISION OF WATER TANK TRUCK (WATER CARTING) TO SUPPLY WATER VARIOUS SCHOOLS (BUFFALO CITY METRO MUNICIPALITY) IN THE EASTERN CAPE.**

BACKGROUND

Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.

1. SCOPE OF WORK

- Service Provider must provide proof from accredited water authority where water was purchased from and job cards to be signed by both parties (Service Provider and the School Principal)
- To utilise the log sheets from Amatola Water when rendering the service of water carting
- Payment of invoices will not be paid if the above is not adhered to.

Note:

• REIMBURSEMENT FOR KILOMETERS

The service provider will only be **reimbursed for water carted** from water source to a delivery point only. The kilometers from home/business premises to water source will not be reimbursed.

• Please do not exceed the purchase order amount as Amatola Water will not be liable for payment thereof.

- The service provider to ensure his/her water truck is roadworthy before carting water.
- The Service Provider to ensure that the water truck comply with any local regulations and standards set by South African authorities:
- The Service Provider of the water truck that used to transport drinking water must ensure that tank/s, associated pipework and equipment used for loading or unloading of portable 13 water have not been used previously for transporting any noxious, toxic or hazardous matter, non-food liquids or human or animal wastes.
- Locality: Attached Municipal Bill, Lease Agreements or Letter from Councilor not older than (12) Twelve months. If property is leased, municipal account of the lessor to be attached.
