#### Phase One: Mandatory Requirements

## 1. BACKGROUND

Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District, and portions of adjoining districts in the central Eastern Cape.

## 2. SCOPE OF WORK

Amatola Water invites suitably qualified and experienced professional service providers to quote on REPAIR BUSHMAN'S BRIDGE CROSSING PIPELINE LEAKS WITH CASCADE CLAMPS AND OR WELDING AS AND WHEN REQUESTED .

## 3. SPECIFICATION

The objective of the tender process is to appoint service providers to submit proposals for the Provision of bulk supply line Repairs in Amatola Water:

### The following is covered in the scope of work:

- The work must be quoted as Labour Rates, Cascade clamping and or Weld.
- The minimum normal hours per day shall be charged at eight hours (8 hrs) per full day.
- The tradesman must be competent to work on heights and confined spaces.
- The supplier/service provider shall submit delivery notes on the work to be performed that will be signed by their representative and Amatola Water representative.
- The tradesman shall comply with the Health and Safety regulations of the Occupational Health and Safety act and use the required PPE.
- The service provider will submit a summary of the Labour hours and kilometres travelled after the work has been done, or after the contract period has seized, which will be certified for payment by the responsible person and Manager according to the weekly records.
- The service provider will submit a Health and Safety file upon appointment or receiving a work order number and must be submitted to our Health and Safety Officer for approval.
- The Service Provider must submit Fall Protection Plan upon appointment.
- Security and liabilities of the Labour is the responsibility of the Service Provider and Amatola Water won't be held responsible for any losses or damages.
- All response times upon callouts should be strictly kept at 3hours throughout the contract.
- Amatola Water reserves the right to increase or decrease the contract period or any part thereof if repair work on the contract is cancelled or work has come to an end. This will be communicated to the contractor in advance when and for how long the contract will be stopped/cancelled/ceases.


