BACKGROUND

Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.

1. SCOPE OF WORK

Description

Repair and replace 1 x 10mm x 60m Overhead cable

Tension 4 x 10mm x 200m Overhead cable

Supply Weatherproof Terminal box with 4 x 80Amps connected to the Overhead cables

60Amp x 4 pole isolator, to be mounted inside the Pump room

Connect 25mm x 4 core x 60m Armoured cable from the terminal box to the isolator inside the pump room

Armoured cable to be sleeved by 3m from ground

25m of armoured cable must be 500mm underground from the Pole to the Pump room.
