BACKGROUND

Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.

1. SCOPE OF WORK

- Construction of paved pedestrian walkway using 60mm thick interlocking paving blocks around Ponds.
- Installation of 450mm diameter Class 50D stormwater pipe including the Construction or precast headwalls.
- Supply, Deliver, Install and Commissioning of an ultrasonic flow measuring device on inlet works, complete.
- Provision of galvanised steel handrails around terminal manhole.
- Supply, Deliver and Installation of a new fine screen at the inlet works.
- Provision of handrakes HDG to suit screen.
- Provision of stone pitching at stormwater channel and cut embarkments.
- Provision of 75mm thick,19mm Road stone walkway around the newly constructed ponds edge restrains (fig 10) to secure 19mm stone walkway including A2 Bidim.
- Provision of stone pitching at outlet of final effluent discharge chamber.
- Provision of new standpipe /tap at Ponds area.
- Provision of nylon safety rope (20mm min) to be secured in concrete rate to include fastening mechanism.
- Fixing of existing leaking plumbing in the school.
