6. JOINT VENTURE REQUIREMENTS

<u>DEFINITION</u>:- "Joint Venture or Consortium": means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

Should a group of companies/firms and/or interested parties wish to enter into a joint venture / consortium agreement the following minimum requirements must be met: -

BACKGROUND

Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.

1. SCOPE OF WORK

1. INTENT:

SHE risks associated with pressurised systems, vessels and portable gas containers are identified, assessed and managed.

2. REFERENCES:

Pressure Equipment Regulations; Reg7, Reg8, Reg9, Reg10, Reg11, Reg14

3. DEFINITIONS:

Portable gas container - means any cylinder or other vessel of which the water capacity by volume is at least 0.5 litres but not exceeding 1200 litres and which is intended for the storage and conveyance of compressed. liquefied or dissolved gasses

Pressure vessel

- means any vessel of which the interior or jacket is under pressure or in which Cushion of gas or vapour can form above the liquid at a pressure in excess of

That of the atmosphere including a diving bell, but does not include:

- 1. a boiler
- a vessel in which the pressure is exerted by a liquid the temperature of which 2. does not exceed the boiling point of the liquid at atmospheric pressure and in which a cushion of gas or vapour cannot for above the liquid.
- the working cylinders or chambers of a steam, heat or air engine. 3.
- a vessel under pressure which forms an integral operating part of a motor vehicle or locomotive running on railway lines.
- a portable gas container. 5.
- 6. a pressurised system.
- a vessel of which the product of the design pressure in pascal and the 7. capacity in cubic metres is less than the figure 15000.
- 8. a vessel of which the design is less than 40 000 pascal gauge pressure.
- a vessel with a nominal with a nominal internal diameter of less than 150mm.

"pressured system" means an assembly of vessels under pressure and includes connections by pipes or similar ducts, fittings and valves which operate under gauge pressure equal to or greater than 40 000 pascal for the process and conveyance of a flammable liquid, hazardous chemical substance, saturated steam or superheated steam.

4. SHE STANDARD

PRESSURE VESSELS ON REGISTER, TESTS AND INSPECTIONS CARRIED OUT.

- All inspections and tests to be carried out on the specified due date and in accordance with standards by appropriately qualified person. Copies of the competent person certificate / qualification to be attached on the register.
- All pressure vessels must be physically identified by means of a manufacturer's plate and / or company identification.

TEST PRESSURE

• The test pressure of the vessel must be correctly marked in the relevant log sheet. The specified pressure must be recorded on the gauge of pressure vessel.

RELIEF VALVES LOCKED OR SEALED

- After tests, all relief (safety) valves physically locked or sealed by the competent person.
- Safety valves are to vent to a safe area.

RED LINE ON PRESSURE GAUGES

- Red lines indicate maximum pressure & are marked on the gauges as per the manufacturer's plate & certificate.
- The legibility of the red line is to form part of competent person's inspection.

6. SCOPE OF WORK

- Each service and inspection must be in rigid accordance with the OHS Act and the Pressure Equipment Regulation
- Perform relevant non destructive examinations on selected areas
- Witness pressure test as required by the OHS Act Regulation, upon completion the competent person must submit a written report and complete the registers in all appropriate areas on the condition of the individual unit coupled with recommended remedial actions as required.
- In cases of repairs, a written quote must be provided.
- All Amatola Water registers of the individual units must be updated on site, no register must be removed from site. A 36 month pressure test register to be issued to Amatola Water Planning Department on completion of the task.
