1. BACKGROUND

Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.

2. <u>Scope</u>

Specification

The objective of this RFQ process is to appoint service provider to submit a proposal for the Provision of earthmoving Equipment in the form of (Excavator and Lowbed) that will be used on Albany Coast Sea Wells and Sand Dunes.

Scope of Work

The Plant machinery will be used on excavating seven boreholes in Diaz that are covered by the sand dunes and dig trenches to cover power supply cables.

Note: The machinery will be established on identified site for an estimated duration, disestablish and reestablished on a different site, this arrangement will be made between the AW official and the Supplier Supervisor of the machinery.

General Conditions of this Contract:

- The service provider to provide a foreman who will be managing the work and the machinery provided. Note the rate of the foreman must be included in your machinery rates to be paid.
- The Plant machinery in the form of Medium excavator must be quoted on an hourly wet rate and have its own operator.
- Excavator needs to be transported or moved to or from site to your depot or to another location.

Km rate only.

- The minimum normal hours per day shall be charged at eight hours (8 hrs) per full day.
- The operator must be trained to excavate a trench within or between surrounding existing services and according to levels provided by the foreman or responsible person.
- Service providers shall submit proof of ownership or lease when submitting his quote.
- The owner of the machine shall submit the daily working hours of the machine every Monday of the week which hours will be compared with the records of the Amatola Water foreman or responsible person. Machine must be equipped with an hour meter which records only when engine is running.
- The operators of the Plant machinery shall comply with the Health and Safety regulations of the Occupational Health and Safety act.

- Plant Machinery requested must be in a good road worthy condition
- The service provider will submit a monthly summary of the hours each month or after the machine has been used, or after the job has been completed if it's a short period, which will be certified for payment by the foreman or responsible person and Manager according to the weekly records.
- Official order will only be issued after physical inspection of the machine for compliance and endorsement by the client.
- The fuelled Excavator, with competent operator who can excavate and or rehabilitate at prescribed slopes with the use of profiles shall be used to make good of the earthworks and will be used for any other general purpose where any Machinery can be used.
- Accommodation, food, PPE and workman's compensation for the Machinery Operators must be arranged by Supplier and be included in the daily rate quoted.
- Successful Service Provider to submit a detailed Health and safety file upon appointment or issue of an order.
- Security and liabilities of the Plant machinery is the responsibility of the Plant Company and Amatola Water won't be held responsible for any losses or damages to the machine.
- Any downtime of the Plant due to own problems e.g. operator not available on site, breakdowns etc. will be deducted from the actual hours worked and must be shown on the daily logbook for reconciliation purposes.
- Any breakdowns or replacement on the machine must be responded to within 24 hrs.
- Plant machinery must be available on site when requested by the successful supplier outside of agreed work hours.
- Amatola Water reserves the right to increase or decrease the contract period or any part thereof if project work on the contract is cancelled or work has come to an end due to budget limits. This will be communicated to the contractor in advance when and for how long the contract will be stopped/cancelled/ceases.


