### **1. DEFINITIONS**

### **1. BID PUBLICATION**

### **2. BID SUBMISSION**

The original completed bid documents must be submitted in a sealed envelope endorsed with the RFQ Number and Bid Description as detailed in the Tender Data. The sealed envelope must be deposited in the RFQ Box, located in the reception area of Amatola House, 6 Lancaster Road, Vincent, East London, not later than the time and date specified on the cover page and SBD 1 of this bid.

### **3. RFQ Evaluation Criteria**

### **5. AUTHORITY TO SIGN BID DOCUMENTS**

In the case of a Bid being submitted on behalf of a company, close corporation or partnership, evidence must be submitted to the Amatola Water at the time of submission of the Bid that the Bid has been signed by persons properly authorised thereto by resolution of the directors or under the articles of the entity.

### **6. JOINT VENTURE REQUIREMENTS**

**DEFINITION:- “Joint Venture or Consortium”:** means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

Should a group of companies/firms and/or interested parties wish to enter a joint venture / consortium agreement the following minimum requirements must be met: -



- a. A properly signed copy of the joint venture/consortium agreement must be attached.
- b. Each member of the joint venture/consortium's taxes must be in order.
- c. After the award of a contract to a joint venture/consortium, the successful joint venture group or consortium must provide a combined joint venture/consortium Tax Clearance Certificate.
- d. After the award of a contract to a joint venture/consortium, the successful joint venture group or consortium must provide the details of the joint venture / consortium banking details.

**7. CONDITIONS OF TENDER**

### **TERMS OF REFERENCE FOR THE PROVISION OF INDEPENDENT EXTERNAL QUALITY ASSURANCE REVIEW (IEQAR) IN LINE WITH THE 2024 GLOBAL INTERNAL AUDIT STANDARDS (GIAS) FOR SIX (6) WEEKS STARTING IN MAY 2026**

Amatola Water invites quotations from suitably qualified and experienced service providers for the Provision of Independent External Quality Assurance Review (IEQAR) in line with the 2024 Global Internal Audit Standards (GIAS)

#### **BACKGROUND**

*Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation.*

#### **SCOPE OF WORK**

##### **1. PURPOSE OF THE PROJECT AND OVERALL OBJECTIVES**

The purpose of this request is to invite suitable bidders who are qualified and experienced to perform an Independent External Quality Assurance Review (IEQAR) in alignment to the Quality Assessment Standard of the Institute of Internal Auditors. The service provider will be required to conduct the assessment, write a report with findings and recommendations at the end of the assessment. This exercise will provide assurance that Amatola Water Internal Audit conforms to the Global Internal Audit Standards (GIAS) and assist in improving its processes. **The total budgeted hours for this assignment is 120 hours.**

##### **2. CONTEXT**

Amatola Water currently operates as a co-sourced internal audit function. The internal audit function is currently capacitated by the Internal Audit Manager, Internal Audit Specialist, Independent Contractor, and two Internal Audit Interns. A panel of co-sourced Service Providers has also been appointed to assist with the provision of Internal Audit Services to the utility for a period of five years.

Amatola Water Internal Audit Function requires the services of a professional firm to perform an External Quality Assessment Review (EQAR) as required by the Global Internal Audit Standards (GIAS).

The Full External Quality Assurance of the Amatola Water's Internal Audit function as required in terms of the Global Internal Audit Standards; Standard 8.4; *"The chief audit executive must*

*develop a plan for an external quality assessment and discuss the plan with the board. The external assessment must be performed at least once every five years by a qualified, independent assessor or assessment team. The requirement for an external quality assessment may also be met through a self-assessment with independent validation. When selecting the independent assessor or assessment team, the chief audit executive must ensure at least one person holds an active Certified Internal Auditor designation.”*

The last assessment for EQAR expired in 2023, hence Amatola Water is required and due to conduct assessment in compliance with the Global Internal Audit Standards.

### **3. PROJECT OBJECTIVES AND DELIVERABLES**

The Quality Assurance review will cover all activities of the Internal Audit Function, including but not limited to:

- 3.1. The appointed service provider shall conduct the quality assessment in accordance with the new Quality Assessment Manual of the Institute of Internal Auditors.
- 3.2. Alignment with the organisation’s strategic objectives and risk management framework.
- 3.3. Adequacy of the audit methodology, policies, and procedures.
- 3.4. Resource management (skills, structure, training, and independence).
- 3.5. Performance monitoring and continuous improvement practices.
- 3.6. Stakeholder satisfaction and perception of audit value.
- 3.7. The review shall include a report with recommendations on the evaluation of the internal audit activity’s conformance with the Global Internal Audit Standards. The Quality Assessment Review will assist Amatola Water’s Internal Audit function to accomplish its objectives by bringing a systematic, disciplined approach to evaluate and improve the effectiveness of risk management, controls, and governance processes. Amatola Water’s Internal Audit function will also implement recommendations from the review process where possible.
- 3.8. Working Paper File - Review of a sample of Manual Audit Working Paper to evaluate compliance to the Global Internal Audit Standards.
- 3.9. The appointed serviced provider must have the capacity, functional skill and experience to provide the services required to assist the Amatola Water’s IAS to accomplish its objectives by bringing a systematic, disciplined approach to evaluate and improve the effectiveness of risk management, controls, and governance processes.

### **4. OBJECTIVES**

4.1 To assess the conformance with the implementation of the new Global Internal Audit Standards including the existence of a quality assurance process and the provision of assurance and advisory services.

4.2 To assess the efficiency and effectiveness of the internal audit activity considering:

- Its Charter,
- The expectations of the Audit & Risk Committee, Executive Management and the CAE. and;
- It's current needs, exposures to performing at less than an effective level, and the future direction and goals of Amatola Water.

4.3 Determine the perception of internal auditing through interviews and surveys with executive management and internal audit customers. To provide insights into the Amatola's Water Internal Audit Activity level of satisfaction with internal auditing's services, along with appropriate suggested changes.

4.4 Examine internal auditing techniques and methodology for testing systems of control.

4.5 Identify ways to enhance policies and practices, as well as coordination with external auditors.

4.6 To identify areas of strength and opportunities for improvement.

4.7 Provide reasonable assurance as to whether the internal audit activity complies with the IIA's Global Internal Audit Standards.

4.8 The external QA team should objectively consider the expectations of the Audit & Risk, Executive Management, and the Chief Audit Executive; and the policies and procedures of Amatola Water and the Internal Audit function. To ensure freedom from bias in the QA, there should not be any relationship, either directly or indirectly, between the organisation and the external QA team that is, or appears to be, a conflict of interest. Such relationships could significantly negate the benefits of the QA.

**Firms currently listed on the Amatola Water Internal Auditors panel are ineligible to submit proposals for this RFQ, as participation would create a potential impairment to independence and objectivity.**
