The original completed bid documents must be submitted in a sealed envelope endorsed with the Bid Number and Bid Description as detailed in the Tender Data. The sealed envelope must be deposited in the Bid/Tender Box, located in the reception area of Amatola House, 6 Lancaster Road, Vincent, East London, not later than the time and date specified on the cover page and SBD 1 of this bid.

## **6. JOINT VENTURE REQUIREMENTS**

**DEFINITION:- “Joint Venture or Consortium”:** means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

Should a group of companies/firms and/or interested parties wish to enter into a joint venture / consortium agreement the following minimum requirements must be met: -

- a. A properly signed copy of the joint venture/consortium agreement must be attached.
- b. Each member of the joint venture/consortium's taxes must be in order.
- c. After the award of a contract to a joint venture/consortium, the successful joint venture group or consortium must provide a combined joint venture/consortium Tax Clearance Certificate.

#### **1. BACKGROUND**

*Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.*

#### **2. SCOPE OF WORK**

The scope of work for the **PROVISION OF CERTIFIED AERIAL INFRASTRUCTURE IMAGING, PROFESSIONAL MULTIMEDIA PRODUCTION, INTERACTIVE DIGITAL INTEGRATION, AND SECURE PRODUCTION OPTIMISATION AND DEPLOYMENT OF THE EXISTING DIGITAL PLATFORM**. The following areas have been scoped into this project. The selected bidder will be required to:

### **SPECIFICATION FOR PROVISION OF CERTIFIED AERIAL INFRASTRUCTURE IMAGING, PROFESSIONAL MULTIMEDIA PRODUCTION, INTERACTIVE DIGITAL INTEGRATION, AND SECURE PRODUCTION OPTIMISATION & DEPLOYMENT OF THE EXISTING DIGITAL PLATFORM**

#### **1. BACKGROUND**

Amatola Water previously procured services for the upgrade and redevelopment of its corporate website. The core redevelopment was completed within a staging environment.

Due to budget limitations under the prior procurement process, certain specialised multimedia production, aerial imaging, interactive visual integration, and secure production deployment components could not be executed at that stage.

This Request for Quotation (RFQ) is therefore issued to procure the outstanding specialised services required to enhance, optimise and securely deploy the existing platform to a production-ready state.

This procurement:

- Does not constitute new website development;
- Does not duplicate the prior website upgrade scope;
- Is limited to multimedia production, certified aerial imaging, interactive integration, and secure production deployment of the existing system.

## **2. PURPOSE**

The purpose of this procurement is to appoint a suitably qualified and experienced Service Provider to:

- Produce certified aerial and ground-based infrastructure imagery;
- Conduct professional executive and board studio photography;
- Develop and integrate an interactive geospatial visual module;
- Complete outstanding system components;
- Optimise, harden and securely deploy the existing Next.js platform to production.

The final outcome must be a secure, fully functional, visually enhanced digital platform aligned with Amatola Water's governance, transparency and public accountability mandate.

## **3. SCOPE OF WORK**

The scope of work comprises three (3) integrated components.

### **3.1 Infrastructure Imaging and Aerial Cinematography**

The Service Provider shall conduct high-resolution visual documentation at:

- Ten (10) Dams
- Eight (8) Water Treatment Plants

Total: Eighteen (18) infrastructure sites.

#### **3.1.1 Aerial Drone Operations**

The Service Provider must:

- Utilise SACAA-certified Remote Pilot Licence (RPL) holders (minimum two);
- Demonstrate experience in industrial or infrastructure aerial operations;
- Ensure full regulatory compliance.

Minimum Technical Standards:

- 4K or 6K capture capability;
- 3-axis stabilised gimbal;
- Obstacle sensing capability;
- Redundant GPS systems;
- Minimum 40-minute flight endurance;
- RAW or LOG colour capture;
- Geo-referenced imagery metadata.

#### **3.1.2 Ground-Based Cinematography**

The Service Provider shall utilise:

- Broadcast-grade cinema cameras (Super 35mm, Mirrorless or Full Frame);

- Minimum 4K UHD resolution;
- LOG or RAW recording;
- Dual-card redundancy;
- Professional audio equipment.

### 3.1.3 Executive and Board Studio Photography

Professional studio portrait sessions must be conducted for:

- Board Members;
- Executive Management;
- Senior Leadership.

The Service Provider must demonstrate:

- Dedicated studio capability (fixed or mobile);
- Professional lighting systems;
- Controlled backdrop setup;
- Professional retouching workflow.

### 3.2 Interactive Infrastructure Visual Integration

The Service Provider shall design and deploy an Interactive Infrastructure Visual Module within the existing platform, incorporating:

- Geospatial mapping framework;
- GPS-linked media assets;
- Clickable infrastructure markers;
- Embedded highlight reels;
- Responsive front-end display.

Integration must align with the existing Next.js architecture without system disruption.

### 3.3 Production Optimisation, Security Hardening and Deployment

The Service Provider shall:

- Complete outstanding system components;
- Conduct regression testing;
- Facilitate User Acceptance Testing (UAT);
- Submit a detailed migration methodology;
