#### **1. BACKGROUND**

*Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.*

#### **2. SCOPE OF WORK**

The scope of work for the HIRING OF A BOREHOLE TRUCK DRILLING MACHINE. The selected bidder will be required to:

### **1&2 Hiring of Borehole Drilling Truck Machine/ Equipment for Nkwezana school Closer to Gonubie**

#### **Purpose:**

- **Hiring of borehole drilling truck machine to carry out the re-drilling and cleaning of an existing borehole that has become blocked by small HDPE and bricks, in order to restore proper water yield and functionality.**

#### **Specifications for Re-Drilling and Cleaning**

##### **1. Description of Work:**

- **Re-drilling and cleaning of the existing borehole.**

**The borehole has a 160 mm diameter and is to be drilled and cleaned down to a depth of 80 meters.**

##### **2. Scope of Work:**

- **Mobilization of drilling truck, crew, and all necessary equipment to site.**
- **Re-drilling of the existing borehole along the same alignment to remove blockages and sediment.**
- **Cleaning and flushing of the borehole using airlifting or jetting method to ensure free water flow.**
- **Development of the borehole until clear water is achieved.**
- **Site demobilization and cleaning after completion of works.**

### **3. Equipment Required:**

- Borehole drilling truck (suitable for 160 mm diameter and up to 100 m depth).
- Compressor for airlifting and cleaning.

### **4. Expected Output:**

- Borehole drilled, cleaned, and developed to 80 meters.

- Submission of drilling log, and completion report.
